<p>Who Should Apply</p>	<p>Young professionals in the United States interested in international development, social entrepreneurship, or business development. Ideal applicants have previously engaged with members of the Fall 2022 PFP cohort as professional hosts or through networking and professional development activities.</p>

PROGRAM DETAILS

With funding from the U.S. Department of State, **CRDF Global** will conduct a two-way exchange **Professional Fellowship Program** (PFP) on the theme of Economic Empowerment for professionals from Algeria, Egypt, Morocco, and Tunisia. The second part of the two-way PFP exchange, the international program, will be implemented in the following three phases over the course of 10 days in Algeria, Egypt, Morocco, and Tunisia:

- **Phase I:** In-country orientation with US Embassy staff and the recently returned Professional Fellows cohort.
- **Phase II:** Engage with a Fall 2022 Fellow in implementing a follow-on project with their place of employment and community during 10-day placement in one of four countries: Algeria, Egypt, Morocco, and Tunisia.
- **Phase III:** Closing Synthesis Session with outbound cohort

This application supports recruitment for the outbound fellowship. The fellowship will take place during any 10-day period from April 26, 2023 – May 20, 2023. Applicants should indicate their availability and preferences of dates in the application.

Using funds provided by the Department of State, CRDF Global will make all necessary travel arrangements and provide travel stipends for all selected fellows for the duration of the fellowship.

The following will be covered by the program:

- International and Domestic Airfare
- Program-related ground transportation
- Lodging
- Meals and Incidental expenses (per diem)
- Limited health benefits policy
- International travel insurance

Any costs incurred as a result of changes to travel arrangements not approved by CRDF Global or personal expenses will be the responsibility of the fellow.

Applicants should be current professionals engaged and interested in one of the following areas:

- Small and medium business development
- Economic development policy
- Social entrepreneurship
- Business administration
- Business education
- Community training programs

As a PFP Fellow, participants are required to actively engage in all program activities. This includes:

- Attendance and participation in pre-departure events.
- Commitment to fellowship dates.
- Daily attendance at fellowship placement and participation in professional development activities.
- Provision of regular reports and updates during fellowship.
- Completion of a final report following fellowship. *Fellows should also be prepared to discuss their experiences and accomplishments with other fellows and to report back to program funders and relevant institutions on how they will apply or have started to apply their new skills after they return to the United States.*
- Completion of all program surveys.
- Completion of final program report.

COVID-19 Disclaimer

In response to the ongoing global pandemic, the PFP arranged by CRDF Global may be offered as a hybrid program with virtual activities leading up to the exchange. Please note: the in-person, international exchange is contingent upon favorable travel conditions. In the event there are travel restrictions, or others factors which could adversely impact the health, safety and welfare of program participants, host organizations, and local communities, CRDF Global may postpone or pivot the planned in-person exchange to virtual programming. CRDF Global will follow available national and local public health guidance when making decisions related to the PFP.

Submission Requirements

Individuals seeking acceptance into the program must:

- Submit a completed application and required supporting documents
- Provide proof of full Covid-19 vaccination at least two weeks prior to departure
